

INVESTMENT OBJECTIVE & POLICY

The investment objective of the Fund is to achieve a total return through a combination of capital growth and income by investing in a globally diversified portfolio of fixed income The Fund invests in a range of Sovereigns, securities. Supranationals and Agencies (together 'SSAs') and corporates predominantly denominated in USD. The Fund may invest up to; 40% of its total net assets in Emerging market bonds, 30% in subordinated corporate debt, including corporate hybrid and TIER2 bonds and 30% of its assets in BB or BB+ rated issues as per the Standard & Poor's ratings. Up to 10% of its Net Asset Value can be invested in unrated bonds excluding convertibles, with exposure to corporate debt in each sector not exceeding 35%, with government bonds and government guaranteed bonds (agencies) being exceptions. Investments in cash or money market instruments including short term government bonds issued by governments and institutions denominated in USD, as well as fixed income securities in a currency other than the base currency up to 20% of NAV are permitted. The Fund may also invest in financial derivatives such as futures, interest rate swaps, warrants and options to indirectly gain exposure to underlying fixed income securities, or use swaps to hedge or reduce credit or default risk of a credit bond market. The Fund will have an averaged ESG score higher than the averaged ESG score of its initial investment universe.
